Land Disturbance -NOTES

- i. AR means actual and reasonable costs of compliance monitoring.
- ii. Earthworks consent annual charges are charged based on the average area (hectares) open on a monthly basis, averaged over the total period of works undertaken during the financial year. See example below:

Month	Hectares Open (average)
January	5
February	7
March	4
April	4
Total Average	5

The annual charge is based on 5 hectares (being the average area on a monthly basis) for a period of 2 to 6 months (LD7) as per table 9.

- iii. Vegetation removal charges are based on the number hectares harvested in the financial year
- iv. Earthworks associated with vegetation removal will be charged in accordance with earthworks schedule.
- v. Riverbed / Lake Works and Diversion of Surface Water annual charges are charged only in the financial year the works are undertaken.
